COMMISSIONERS' REPORTS

Commissioner Heimel reported on his conversations with Pa. Dept. of Conservation and Natural Resources officials on rehabilitation and development of Denton Hill State Park. Two potential private-sector partners responded to DCNR's request for proposals. Officials will be meeting with each of them to determine if terms can be negotiated for developing the park into a four-season attraction. Commissioner Heimel also discussed one of the county's Operational Improvement Initiatives, involving new partnerships for strategic and coordinated community and economic development.

Commissioner Hayman commented on the Denton Hill State Park issue, emphasizing that a four-season strategy and a higher financial outlay by the state would likely be needed to make the proposed private/public partnership sustainable.

Commissioner Grupp provided updates on issues raised earlier concerning the county's 911 emergency communications system. She noted that county officials are seeking FCC licensure for a new frequency, as requested by representatives of local emergency services agencies.
