- Cash balances agree with bank statements.
- Revenue receipts agree with deposits and bank statements.
- Invoices proved satisfactory against General Ledger.
- In- County meal purchases are still being reimbursed. This is a breach of the Union Contract (Pg. 31, Section 9, No. 4, Meal Allowance) which states õonly applicable if the employee is engaged in the affairs or activities of the employer, while traveling or in attendance, <u>outside</u> the County of Potter for a continuous period of not less than eight (8) hoursö.

OPINIONS:

- Inventory should be kept for each department. Suggest through computer program.
- There should be dual control on all bank accounts, one being an elected official or deputy. Two signatures required on all checks.
