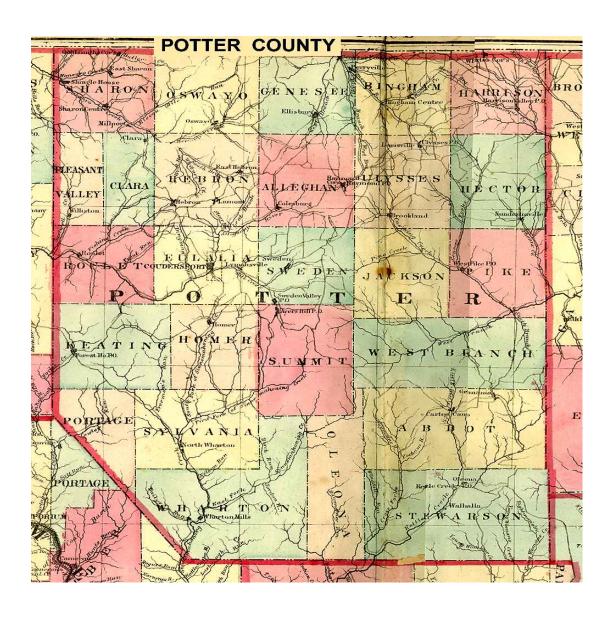

- We continue to see a lapse in backup detailed receipts for credit card meal purchases.
