## **Potter County Partners With VA To Expand Services**



Service members, veterans, and their families who reside in rural communities have unique needs and face a variety of challenges accessing quality health care. In response, the U.S. Dept. of Veterans Affairs (VA) has encouraged public officials in rural areas to develop partnerships that will allow the VA to extend its reach. The Potter County Board of Commissioners accepted the challenge, developing a collaborative arrangement with the Bath (N.Y.) VA Medical Center that continues to pay dividends in improving local veterans' access to care. Bath VA has expanded operation

hours at its medical clinic, located in a county-owned building at Mapleview, just off Rt. 872 in Coudersport. Services are now available Mondays and Thursdays, from 8 am to 4 pm. The clinic is staffed by personnel trained to process new enrollments; update patient information; conduct screenings; provide medication, prescription renewals and lab work; and deliver primary care and/or referrals, depending on each veteran's needs. Most recently, Bath VA and the commissioners have been working on an expansion of services beyond the traditional primary care model, to include "telemedicine" and "telepsychiatry" through advanced video technology. Meanwhile, Potter County Commissioner Paul Heimel is advocating for rural veterans' services as vice chairman of the National Veterans and Military Service Committee, a branch of the National Association of Counties. He was part of a study group making the case for additional federal support for rural veterans with research findings, such as:

- A higher proportion of rural veterans than urban or suburban vets report disorders; 26% report experiencing PTSD; 18% report depression; rates of alcoholism and suicide ideation are also higher among rural veterans.
- Rural veterans have more barriers to care transportation, geographic distance from qualified providers (due in part to rising difficulties rural health care providers are facing in recruiting qualified professionals);
- Rural veterans are less likely to seek care due to cultural pressures.
- A large proportion of rural veterans are not well informed of VA services. Just 41% percent show a basic knowledge of benefits and services to which they are entitled. Of those, 26% do not have clear knowledge of how to apply.

### **County Office Spearheads 'Support Our Troops'**

Filling of care packages for soldiers began recently through a project being spearheaded by the Potter County Office of Veterans Affairs. Family members or friends of service members who would appreciate packages are encouraged to provide names and mailing addresses. Donations of cash and package items are being accepted. Among the items being packed are snacks, personal care items, reading materials, writing supplies, playing cards, DVDs, video games, compact discs and games. ## **Helping Vets File Electronic Benefits Claims**



Potter County Veterans Affairs Director Will Worthington has registered for training to help local veterans use electronic filing to apply for medical benefits and other services. The VA reports that wait time for claim processing is reduced by about 50% if a claim is filed by computer rather than on paper.

### **Veterans Designation Now On Driver's Licenses**

A new law allows for a designation on a Pennsylvania Driver's License or Identification Card that clearly indicates the bearer is a veteran of the United States Armed Forces. Qualified applicants include those who have received a certificate of release or discharge from active duty (DD214) or equivalent for service in the Armed Forces, including a reserve component or



the National Guard – as long as they were discharged or released from such service under conditions other than dishonorable. The designation includes an American flag. It can be helpful to veterans seeking discounts from retailers and to those who view the license or ID card while delivering certain services.

The marketer seeks personal information, including credit card numbers. The numbers are: 1-800-872-1000 (VBA main number is 1-800-827-1000); and 1-888-442-4511 (GI Bill number is 1-888-442-4551).

**Show Your Support**. An "Honoring Our Veterans" license plate is available to all Pennsylvania motor vehicle owners from PennDOT. The plate features an American flag and an eagle with the words "Honoring Our Veterans." Cost is \$35, with \$15 from each sale going to a Veterans Trust Fund to provide grants to veterans' service organizations and other veterans' causes.

<u>Academic Credits.</u> Media reports have generated confusion over new policies granting academic credits that

recognize the intense training and experience gained by veterans and active military members. Some academic counselors suggest that service members should use credit-by-exam programs, such as College Level Examination Program (CLEP) tests. Only a portion of credits are usable toward a degree. Others end up on a transcript as "general education." Colleges are adapting, relying in part on the new Joint Services Transcript.

<u>Dental Insurance Program.</u> VA is partnering with two providers to allow eligible veterans and family members to purchase affordable dental insurance. This benefit is designed for veterans with no dental coverage, or those eligible for VA dental care who would like to purchase additional coverage.
