COMMISSIONERS' REPORTS

Commissioner Kefover reported that she spoke at the National Honor Society induction ceremony in Galeton. She discussed a disturbing social trend that has been identified -- the lack of listening skills -- and emphasized the importance of listening to the well-being of individuals, organizations and society.

Commissioner Heimel reported on results from the public opinion polling held as a foundation for the Northern Pa. Tri-County Comprehensive Plan (Potter, McKean and Cameron). With 2,400 survey responses tallied, the top issues identified were business attraction and workforce development; protection of clean air, water and natural places; expansion of infrastructure (including public works and high-speed internet); enhanced attractions for tourism and recreation; strengthening downtown amenities and community services; investing in expanded housing; and addressing issued related to drug addiction.

Commissioner Morley announced that after considering multiple factors he has decided not to seek re-election for the 2020-23 term.
