**Section 1921. Appropriations to Veterans' Organizations for Expenses of Memorial Day, Veterans' Day, Flag Day and Independence Day.** — (Hdg, amended Nov. 3, 1999, P.L. 461, No. 42) (a) The board of commissioners may appropriate, annually, to each camp of the United Spanish War Veterans, and to each post of the American Legion, and to each post of the Veterans of Foreign Wars, and to each post of the Veterans of World War I of the U.S.A. Inc. and to each post of the American War Veterans of World War II (AMVETS), and to each post of the Society of the Twenty-eighth Division. AEF, Incorporated, and to each post of the Italian American War Veterans of the United States, Incorporated, and to each detachment of the Marine Corps League, and to each Naval Association, and to each post of the Guard Army of the Republic, and to each post of the Disabled American Veterans of World War, and to each organization of American Gold Star Mothers, and to each organization of ex-service persons incorporated under the act of April 29, 1874 (Pamphlet Laws 73) and the supplements thereto, in the county, any sum budgeted to aid in defraying the expenses of Memorial Day, Veterans' Day, Flag Day, and Independence Day. ((a) amended November 3, 1999, P.L. 461. No. 42)

(b) Where the Grand Army of the Republic has ceased to exist or to function, such appropriation may be made to the Sons of Union Veterans of the Civil War or, in the absence of such order, to a duly constituted organization which conducts the decorating of graves of Union Veterans of the Civil War.

© Such payments shall be made to defray actual expenses only. Before any payment is made, the organization receiving the same shall submit verified accounts of their expenditures.
