#### **COMMISSIONERS' REPORTS**

Comm. Heimel cited recent statistics reflecting a surge of military veterans enrolling for health care benefits through the U.S. Dept. of Veterans Affairs, adding that the commissioners' decision to establish a second full-time position in the county's Veterans Services Department was well-timed.

Comm. Grupp encouraged residents to reach out to state lawmakers asking for an increase in funding for county-delivered services for senior citizens. State allotments have not increased since 2009. The Potter County Area Agency on Aging has been forced to establish waiting lists for some of its services. She added that the state is carrying a surplus into negotiations on the 2024-25 budget and should dedicate a portion of the revenue for counties.

He also announced that Post 192 will again sponsor the Memorial Day parade and ceremony at the county seat. Lastly, he commended Potter County Maintenance Director Joe Kurtz and his crew for renovations underway at the former VA Medical Clinic in east Coudersport.
