NOTICE TO VOTERS

IF YOUR PRECINCT IS HOMER TOWNSHIP,
PORTAGE TOWNSHIP OR WHARTON TOWNSHIP.

A PROGRAMMING ERROR WAS DETECTED FOR AUSTIN SCHOOL DISTRICT BOARD REGION III. THE ERROR WOULD HAVE INCORRECTLY ALLOWED A VOTE FOR ONE. THE NEW BALLOT WILL BE CORRECTED TO VOTE FOR TWO- PORTAGE AND WHARTON TOWNSHIPS.

A PROGRAMMING ERROR WAS DETECTED IN WHICH A CONSTABLE CONTEST WAS NOT ON THE PREVIOUS BALLOT FOR HOMER TOWNSHIP. THE NEW BALLOT WILL INCLUDE A CONSTABLE CONTEST.

POTTER COUNTY DID NOT HAVE CANDIDATES IN THESE CONTESTS.

PURSUANT TO 25 P.S. § 2970, THE POTTER COUNTY BOARD OF ELECTIONS IS MAKING EVERY ATTEMPT POSSIBLE TO CORRECT THE AFFECTED BALLOTS BEFORE ELECTION DAY AND PURSUANT TO A COURT ORDER DATED OCTOBER 17, 2023, ON ELECTION DAY, VOTERS IN HOMER, PORTAGE, AND WHARTON TOWNSHIPS WILL BE VOTING BY PAPER BALLOT.

ANY VOTERS OF HOMER, PORTAGE, OR WHARTON TOWNSHIPS THAT HAVE RECEIVED BUT HAVE NOT RETURNED THE MUNICIPAL ELECTION MAIL-IN OR ABSENTEE BALLOTS ARE ASKED TO DISREGARD THE ORIGINAL BALLOT, AND TO WAIT UNTIL A NEW UPDATED BALLOT IS ISSUED TO YOU BY MAIL. ANY VOTERS OF HOMER, PORTAGE, OR WHARTON TOWNSHIPS WHO HAVE ALREADY RETURNED MAIL-IN OR ABSENTEE BALLOTS, WE ASK THAT YOU PLEASE RE-VOTE THE NEW UPDATED BALLOT YOU WILL RECEIVE AND RETURN IT AS INSTRUCTED.

ANY PREVIOUSLY RETURNED MAIL-IN OR ABSENTEE BALLOTS ARE SEGREGATED.

PLEASE NOTE ALL UPDATED BALLOTS WILL BE DISTINGUISHABLE BY A GREY STRIP AT THE TOP OF THE BALLOT ON THE FRONT PAGE.
