## **COMMISSIONERS' REPORTS**

Commissioner Heimel provided updates on DNCR's plans to make multiple improvements to Cherry Springs State Park and the department's efforts to contract with a private-sector partner to develop Denton Hill State Park into a four-season attraction.

Commissioner Hayman discussed the county's Blight Reduction Program, following provisions of Pa. Act 153. A \$15 fee on records filed at the Register and Recorder office goes into a blight reduction fund that has grown to \$42,000. Townships and boroughs can apply for funds to help pay for demolition and site restoration qualifying properties. A committee uses specific criteria to review the applications.
